The applicant **City of North Las Vegas**, hereby make application for permission to change the **Point of Diversion, Place of Use.** of water heretofore appropriated under **Permit No. 23869, Certificate No. 7000**

1. The source of water is **Las Vegas Artesian Basin (underground)**
2. The amount of water to be changed **0.350 cfs, but not to exceed 10.0 MG annually**
3. The water to be used for **Municipal Purposes**
4. The water heretofore permitted for **Municipal Purposes**
5. The water is to be diverted at the following point **NE $\frac{1}{4}$  NE $\frac{1}{4}$  Section 11, T.20S., R.61E., M.D.B.&M. or at a point from which the NE corner of said Section 11 bears N. 6 degrees 51' 49" E., a distance of 520.87 feet.**
6. The existing permitted point of diversion is located within **SW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 18, T.20S., R.61E., M.D.B.&M. or a point from which the S $\frac{1}{4}$  corner of said Section 18 bears S. 19 degrees 11' 36" W., a distance of 1386.88 feet.**
7. Proposed place of use **See Attached**

9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Deep well with turbine pump and 100 h.p. electric motor.**
12. Estimated cost of works **\$50,000**
13. Estimated time required to construct works **Completed: 982' deep, 14" cased well.**
14. Estimated time required to complete the application of water to beneficial use **2 years**
15. Remarks: **The Point of Diversion is a well that is part of the municipal supply for the North Las Vegas Service District, which currently serves approximately 33,000 municipal customers. Consumptive use, including surface and ground water, will be approximately 36,000 acre-feet.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 23869 Certificate 7000 is issued subject to the terms and conditions imposed in said Permit 23869 Certificate 7000 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.35 cubic feet per second, but not to exceed 10.0 million gallons annually.
