The applicant Donald J. and Donna R. Zenz, hereby makes application for permission to change the Place of Use of water heretofore appropriated under a portion of Permit No. 28076

1. The source of water is underground
2. The amount of water to be changed 0.06431 cfs 4.50 acre feet annually
3. The water to be used for Irrigation and Domestic
4. The water heretofore permitted for Irrigation and Domestic
5. The water is to be diverted at the following point the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 16, Township 22 North, Range 21 East, Mount Diablo Meridian at a point from which the southwest corner of said Section 16 bears South 10 56'12" West, 4079.29 feet. (Well No. 5) See Permit 28076.
6. The existing permitted point of diversion is located within
7. Proposed place of use See attached Item 7
8. Existing place of use NW NW Sec 16, east 1.125 ac of west 1.75 ac. Parcel 91, T.22N., R.21E. M.D.M., as tabulated on that certain map titled "Exhibit Map Supporting the Conveyance of Water Rights by MCO Properties, Inc. - Palomino Valley, Nevada", Filed as map no. 28071 in the Office of the Nevada State Engineer.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works exist. well, pump, pipeline, sprinkler irrigation system.
12. Estimated cost of works \$150,000
13. Estimated time required to construct works existing
14. Estimated time required to complete the application of water to beneficial use within two weeks
15. Remarks: See Map No. 28071 for existing point of diversion and place of use. See Map No. 55603 for proposed point of diversion and place of use. This application would permit TEMPORARY use of water to grow a crop on a total of 398.84 acres within the described place of use. Oppio Zenz agreement is forth coming.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 28076 Certificate 8518 is issued subject to the terms and conditions imposed in said Permit 28076 Certificate 8518 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 55603, 55604, 55605, 55606, 55607, 57444, 57445, 57446, 57447, 57448, 62157-T, 62158-T, 62159-T, 62160-T, 62161-T, 62162-T, 62163-T, 62164-T, 62165-T, and 62166-T shall not exceed 1,088.87 acre-feet annually.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Failure to use the water during the specific period under this permit will result in the forfeiture of the permittee's portion of Permit 28076, Certificate 8518.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on October 27, 1997 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0643 cubic feet per second, but not to exceed 4.5 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:
