The applicant **Methodist Episcopal Church**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **0.1 c.f.s.** second-feet
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **quasi-municipal and domestic**
4. If use is for:
  - (a) Irrigation, state number of acres to be irrigated
  - (b) Stockwater, state number and kinds of animals to be watered
  - (c) Other use (describe fully under No. 12. "Remarks")
  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **NW¼ SW¼ Sec. 30, T.11N., R.24E., M.D.B.&M.**, or at a point from which the **W¼ corner of said Sec. 30 bears N 20°54'45" W a distance of 189.51 feet.**
6. Place of Use **portion of the NW¼ SW¼ Sec. 30, T.11N., R.24E., M.D.B.&M.**
7. Use will begin about **January 1** and end about **December 31**, of each year.
8. Description of proposed works **well, pump and distribution system**
9. Estimated cost of works
10. Estimated time required to construct works **2 years**
11. Estimated time required to complete the application of water to beneficial use **3 years**.
12. Remarks: **The water is to be used for the parson's residence, church, meeting hall, and landscaping purposes with an estimated annual use of 4 acre feet.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1 cubic feet per second, but not to exceed 4.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

November 15, 1998

Proof of completion of work shall be filed before:

December 15, 1998

Application of water to beneficial use shall be filed on or before:

November 15, 2001

Proof of the application of water to beneficial use shall be filed on or before:

December 15, 2001

Map in support of proof of beneficial use shall be filed on or before:
