The applicant **Kyle Canyon Water District**, hereby makes application for permission to change the **manner of use, place of use, and point of diversion of a portion** of water heretofore appropriated under **Permit No. 22736, Certificate No. 8581**

1. The source of water is **Underground**
2. The amount of water to be changed **.20 cfs**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Quasi-municipal and domestic**
5. The water is to be diverted at the following point **NW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 26, T.19S., R.56E., M.D.B.&M., or at a point from which the SE corner of said Section 26 bears S. 45°49'24" E., a distance of 2948.10 feet.**
6. The existing permitted point of diversion is located within **NE $\frac{1}{4}$  SE $\frac{1}{4}$  Section 26, T.19S., R.56E., M.D.B.&M., or at a point from which the SE corner of said Section 26 bears S. 34°39'12" E., a distance of 2062.23 feet. (Map filed August 25, 1965 under Permit No. 22736)**
7. Proposed place of use **N $\frac{1}{2}$  NW $\frac{1}{4}$ , N $\frac{1}{2}$  NE $\frac{1}{4}$ , Sec. 32 and Sec. 31 all located in T.19S., R.57E., and NW $\frac{1}{4}$ , NE $\frac{1}{4}$  Sec. 36, SW $\frac{1}{4}$  Sec. 25, E $\frac{1}{2}$  SE $\frac{1}{4}$ , NW $\frac{1}{4}$  SE $\frac{1}{4}$  Sec. 26 all located in T.19S., R.56E.**
8. Existing place of use **N $\frac{1}{2}$  NW $\frac{1}{4}$  Section 36, SW $\frac{1}{4}$  SW $\frac{1}{4}$  Section 25, and the E $\frac{1}{2}$  SE $\frac{1}{4}$  Section 26, all in T.19S., R.56E., M.D.B.&M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Deep well, pipeline, storage tanks, and distribution system.**
12. Estimated cost of works **\$450,000**
13. Estimated time required to construct works **Two years**
14. Estimated time required to complete the application of water to beneficial use **Five years**
15. Remarks: **This application changes manner of use, place of use, and point of diversion of a portion of the water under Permit No. 22736, Certificate No. 8581.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 22736 Certificate 8581 is issued subject to the terms and conditions imposed in said Permit 22736 Certificate 8581 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 62265, 62266, 62267 and 62268 shall not exceed 156.70 million gallons annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.20 cubic feet per second, but not to exceed 47.18 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

February 18, 1999

Proof of completion of work shall be filed before:

March 18, 1999

Application of water to beneficial use shall be filed on or before:

February 18, 2002

Proof of the application of water to beneficial use shall be filed on or before:

March 18, 2002

Map in support of proof of beneficial use shall be filed on or before:
