The applicant World Properties, Inc., a Nevada corporation, hereby makes application for permission to change the point of diversion, place of use, and manner of use of a portion of water heretofore appropriated under claims 673 and 674, Truckee River Decree

1. The source of water is Steamboat Creek
2. The amount of water to be changed 458.545 AFS
3. The water to be used for construction (dust control)
4. The water heretofore permitted for as decreed
5. The water is to be diverted at the following point NE $\frac{1}{4}$  SE $\frac{1}{4}$  Section 13, T17N, R19E, MDM, at a point from which the NE corner of Section 13 bears N 18°03' E, 2865 feet.
6. The existing permitted point of diversion is located within as decreed  
Claim 673: NW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 13, T17N, R19E, MDM  
Claim 674: NW $\frac{1}{4}$  Section 18, T17N, R20E, MDM

9. Use will be from January 1 to December 31 of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion, place of use and manner of use of a portion of the waters of the Truckee River as heretofore granted under Claims 673 and 674, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on November 17, 1997 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.555 cubic feet per second, but not to exceed 458.5 acre-feet as decreed.

Work must be prosecuted with reasonable diligence and be completed on or before:






