The applicant Joseph E. & Laurel D. Roderick, hereby makes application for permission to change the Point of Diversion of a portion of water heretofore appropriated under Permit No. 58481

1. The source of water is underground
2. The amount of water to be changed .68 cfs
3. The water to be used for irrigation
4. The water heretofore permitted for irrigation
5. The water is to be diverted at the following point SE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 1, T12N, R25E MDB&M, or at a point from which the NE corner of said Section 1 bears N. 45°45'47" E., a distance of 3,761.34 feet Application No. 28195 Cert. of Record No. 10462, Book 35, Page 10462
6. The existing permitted point of diversion is located within NE $\frac{1}{4}$  SE $\frac{1}{4}$  Section 1, T12N, R25E MDB&M, or at a point from which the NE corner of said section 1 bearing N 10°31'55" E a distance of 4023.49 feet
7. Proposed place of use entire NW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 1, T12N R25E, MDB&M. Total 40 acres.
8. Existing place of use Same as proposed place of use
9. Use will be from March 1st to October 1st of each year.
10. Use was permitted from March 1st to October 1st of each year.
11. Description of proposed works existing well and pump and distribution system.
12. Estimated cost of works 0
13. Estimated time required to construct works 0
14. Estimated time required to complete the application of water to beneficial use N/A
15. Remarks: This temporary application is to change the point of diversion only. The water is still to be used on the same existing 40 acre parcel, by sprinkler irrigation. P.O.U. will remain the same under Permit No. 58481.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 58481 Certificate 14548 is issued subject to the terms and conditions imposed in said Permit 58481 Certificate 14548 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 62583-T and 62813-T shall not exceed 154.0 acre-feet per season.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on October 1, 1997 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.47 cubic feet per second, but not to exceed 100.1 acre-feet per season, and not to exceed a seasonal duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:
