The applicant Newmont Exploration Ltd. and Paul M. Pettit, Agent, hereby makes application for permission to change the point of diversion and place of use of a portion of water heretofore appropriated under Permit No. 46346

\*\*\*\*\*

1. The source of water is underground, RPW-1
2. The amount of water to be changed 2.0 cfs
3. The water to be used for mining, milling and domestic
4. The water heretofore permitted for mining and milling
5. The water is to be diverted at the following point within the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 09, T31N, R54E, M.D.B.&M., at a point from which the NE corner of said Section 09 bears N 30°53'21" E at a distance of 1706.59 feet. See water rights survey map filed under permit 51810.
6. The existing permitted point of diversion is located within within the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 04, T31N, R45E, M.D.B.&M., at a point from which the SE corner of said Section 04 bears S 27°08'53"E a distance of 556.05 feet.
7. Proposed place of use E $\frac{1}{2}$  of Section 08, all of Sections 1,2,3,10,11,12 & 14, T31N, R53E, M.D.B.&M.; all of Sections 34 & 35, T32N, R53E, M.D.B.&M.; all of Section 31, T32N, R54E, M.D.B.&M.; all of Sections 4-6, & 18, T31N, R54E, M.D.B.&M. (See map filed under permit 51810.)
8. Existing place of use E $\frac{1}{2}$  of Section 08, all of Sections 1,3,10,12 & 14, T31N, R53E, M.D.B.&M.; all of Sections 34 & 35, T32N, R53E, M.D.B.&M.; all of Section 31, T32N, R54E, M.D.B.&M.; all of Sections 4-6, & 18, T31N, R54E, M.D.B.&M.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works drilled and cased well equipped with motor, pump and pipeline to place of use (see Proof of Completion filed under permit 51810).
12. Estimated cost of works Completed
13. Estimated time required to construct works Completed
14. Estimated time required to complete the application of water to beneficial use 1 year

15. Remarks: Newmont hereby requests temporary water rights to replace those expired under permit 51810 for continued use of Well RPW-1. Application is herewith made separately for permanent water rights. Any permit issued under this application will be withdrawn upon issuance of permanent water rights.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 46346 is issued subject to the terms and conditions imposed in said Permit 46346 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 44052, 44056, 46346, 47341, 50078, 50079, 50080, 50243, 52253, 62634-T and 62636-T shall not exceed 587.8 million gallons annually. The total combined diversion rates of Permits 44052, 44056, 46346, 47341, 50078, 50079, 50080, 50243, 52253, 62634-T and 62636-T shall not exceed 6.0 cubic feet per second.

This temporary permit is issued under the preferred use provisions of NRS Chapter 534. The manner of use of water under this permit is by nature of its activity a temporary use and any application to change the manner of use granted under this permit will be subject to additional determination and evaluation with respect to the permanent effects on existing rights and the resource within the ground water basin.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

A monthly report shall be submitted to the State Engineer within 10 days from the end of each month which shall include the amount of water pumped from the well and the amount of water used.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on January 13, 1998 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

(PERMIT TERMS CONTINUED)

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, but not to exceed 196.0 million gallons annually.
