The applicant **HOMESTAKE MINING COMPANY OF CALIFORNIA**, hereby makes application for permission to change the **place and manner of use of a portion** of water heretofore appropriated under **Permit 22290, Certificate 7510**

1. The source of water is **underground**.
2. The amount of water to be changed **1.0 cfs, 242 acre-feet annually**
3. The water to be used for **mining, milling and domestic purposes**
4. The water heretofore permitted for **irrigation and domestic**
5. The water is to be diverted at the following point **within Lot 4 (NW $\frac{1}{4}$ NW $\frac{1}{4}$) Sec. 32, T.20N., R.53E. M.D.B.&M., at a point from which the NW corner of said Section 32 bears N. 57°28' W., a distance of 560.0 feet.**
6. The existing permitted point of diversion is located within
7. Proposed place of use **within the W $\frac{1}{2}$ Sec. 2, Sec. 3, E $\frac{1}{2}$ Sec. 4, NE $\frac{1}{4}$ Sec. 9, Sec. 10, W $\frac{1}{2}$ Sec. 11, NW $\frac{1}{4}$ Sec. 14 and the N $\frac{1}{2}$ Sec. 15, all within T.19N., R.53E., MDB&M.**
8. Existing place of use **40 acres within Lot 5, 10.25 acres within Lot 4, and 10.25 acres within Lot 3, all within Sec. 32, T.20N., R.53E., MDB&M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Drilled and cased wells, pump and motor, pipeline from wells to storage reservoir and place of use.**
12. Estimated cost of works **\$200,000**
13. Estimated time required to construct works **Two years**
14. Estimated time required to complete the application of water to beneficial use **Five years**
15. Remarks: **This right will be commingled with the right which changes Permit 19411. It is anticipated that each application to change, when granted, will be able to produce 1.0 cfs with a duty of 242 acre-feet. The total duty used at the mine site is anticipated to be 484 acre-feet annually, with the utilization of both wells. Water not used for mining, milling and domestic purposes will continue to be used for irrigation purposes in the remaining certificated place of use.**
