The applicant Rosemarie Ricks, hereby makes application for permission to change the point of diversion and place of use of a portion of water heretofore appropriated under Permit No. 14576 Certificate No. 5329

\*\*\*\*\*

1. The source of water is under ground
2. The amount of water to be changed 10 acre feet 0.10 cfs
3. The water to be used for irrigation and domestic purposes.
4. The water heretofore permitted for irrigation and domestic purposes.
5. The water is to be diverted at the following point SE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 34, T19S, R53E, MDB&M Nye County Nevada or at a point from which the center  $\frac{1}{4}$  corner of said Section 34 bears S 26 $^{\circ}$  21' 39" E a distance of 680.27 feet.
6. The existing permitted point of diversion is located within SE $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 34, T.19S., R.53E., M.D.B.&M. or at a point from which the N $\frac{1}{4}$  corner of said Sec. 34 bears N. 0 $^{\circ}$  57'E., 2553 feet.
7. Proposed place of use being a portion of the SE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 34, T19S, R53E, MDB&M Nye County Nevada and being Lots 6, 7, 8 and 9, Block 7 of Rancho Del Sol Subdivision Unit 3 File No. 49565 Nye County Records. Containing 4.39 acres $\pm$ .
8. Existing place of use being the S $\frac{1}{2}$  of the NW $\frac{1}{4}$  of Section 34, T19S, R53E, MDB&M, Nye County Nevada and the S $\frac{1}{2}$  of the NE $\frac{1}{4}$  of Section 33, T19S, R53E, MDB&M, Nye County Nevada consisting of 160 acres. (9.828 acres removed)
9. Use will be from January 1st to December 31st of each year.
10. Use was permitted from January 1st to December 31st of each year.
11. Description of proposed works existing well with casing 140 $\pm$  feet deep, submersible pump and pressure tank. Irrigation methos to be determined.
12. Estimated cost of works \$5000.00
13. Estimated time required to construct works 1 year (see item 11 above)
14. Estimated time required to complete the application of water to beneficial use 3 years.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 14576, Certificate 5329 is issued subject to the terms and conditions imposed in said Permit 14576, Certificate 5329 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The total combined duty of water under Permits 62674 and 62675 shall not exceed 16.50 acre-feet and is limited to the irrigation of 3.30 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.10 cubic feet per second, but not to exceed 10.0 acre-feet annually, and not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

July 12, 2001

Proof of completion of work shall be filed before:

August 12, 2001

Water must be placed to beneficial use on or before:

July 12, 2003

Proof of the application of water to beneficial use shall be filed on or before:

August 12, 2003

Map in support of proof of beneficial use shall be filed on or before:

August 12, 2003
