The applicant Central Nevada Utilities Company, hereby makes application for permission to change the Point of Diversion, Place and Manner of Use of water heretofore appropriated under Permit 49292

1. The source of water is Underground
2. The amount of water to be changed 0.056 c.f.s, 16.74 AFA
3. The water to be used for Municipal
4. The water heretofore permitted for Irrigation and Domestic
5. The water is to be diverted at the following point NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 31, T.20 S., R.54 E., MDM, or at a point from which the N $\frac{1}{4}$ corner of said Section 31 bears North 45° 00' East, 141.1 feet (Well No. 8)
6. The existing permitted point of diversion is located within NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 1, T.21 S., R.53 E., MDM, or at a point from which the N $\frac{1}{4}$ corner of said Section 1 bears North 7° 47' 40" East, 357.00 feet
7. Proposed place of use See Attached
8. Existing place of use a portion of NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 1, T.21 S., R.53 E., MDM, 3.35 acres irrigated
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of the waters of an underground source as heretofore granted under Permit 49292 is issued subject to the terms and conditions imposed in said Permit 49292 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 38343, 45870, 45892, 45893, 45894, 45895, 45897, 46116, 46117, 46118, 46119, 46304, 46305, 46306, 46307, 46308, 46309, 46310, 46312, 46313, 46314, 46315, 46316, 46317, 46318, 46319, 46320, 46324, 46325, 46326, 46826, 46827, 47074, 47141, 47265, 48497, 49545, 50722, 50804, 50805, 51142, 52128, 52129, 52130, 52131, 52132, 52284, 52285, 52286, 52606, 52978, 54357, 54359, 54360, 54361, 55101, 55347, 57877, 57879, 57880, 58626, 58627, 58628, 58629, 58630, 58631, 58632, 58633, 58958, 58959, 61065, 61968, 61969, 62037, 62038, 62716, 62717, 62726, and 62920 shall not exceed 19,438.14 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.056 cubic feet per second, but not to exceed 16.74 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

February 20, 1999

Proof of completion of work shall be filed before:

March 20, 1999

Application of water to beneficial use shall be filed on or before:

February 20, 2000

Proof of the application of water to beneficial use shall be filed on or before:

March 20, 2000
