The applicant Elko Summit Limited, hereby makes application for permission to change the Point of Diversion and Place of Use of a Portion of water heretofore appropriated under Permit No. 52510

1. The source of water is underground (Well 16A)
2. The amount of water to be changed 7.28 acre-feet.
3. The water to be used for Quasi-Municipal (Residential Land Development)
4. The water heretofore permitted for Quasi-Municipal
5. The water is to be diverted at the following point NW $\frac{1}{4}$  SW $\frac{1}{4}$  Section 25, T.34N., R.55E., M.D.B.&M. or at a point from which the SE corner of said Section 25 bears S. 70° 32' 47" E., 4879.26 feet.
6. The existing permitted point of diversion is located within NW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 20, T.35N., R.56E., M.D.B.&M. or at a point from which the NW corner of said Section 20 bears N. 83° 20' 04" W., 3141.95 feet.
7. Proposed place of use Section 25, T.34N., R.55E., M.D.B.&M.
8. Existing place of use NW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 20, T.35N., R.56E., M.D.B.&M.
9. Use will be from Jan. 1 to Dec. 31 of each year.
10. Use was permitted from Jan. 1 to Dec. 31 of each year.
11. Description of proposed works Well, pump, motor, 10,000 gallon storage tank and pipelines to the place of use.
12. Estimated cost of works \$40,000
13. Estimated time required to construct works 1 year
14. Estimated time required to complete the application of water to beneficial use 1 $\frac{1}{2}$  years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 52510 is issued subject to the terms and conditions imposed in said Permit 52510 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued for the service of six homes located on Parcels A through D on Lot 15 and Parcels A and C on Lot 14, all in Elko Summit Estates.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.243 cubic feet per second, but not to exceed 7.28 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

September 9, 1998

Proof of completion of work shall be filed before:

October 9, 1998

Application of water to beneficial use shall be filed on or before:

September 9, 2000

Proof of the application of water to beneficial use shall be filed on or before:

October 9, 2000


