The applicant Nevada First Corporation hereby makes application for permission to change the place of use of a portion of water heretofore appropriated under Permit No. 26970 Certificate 8531

1. The source of water is an underground source.
2. The amount of water to be changed 1.094 cfs.
3. The water to be used for irrigation and domestic use.
4. The water heretofore permitted for irrigation and domestic use.
5. The water is to be diverted at the following point unchanged SE1/4 NW1/4 of Section 30, T.37N., R.40E., MDB&M or at a point from which the SE corner of said Section 30 bears S 33° 14' E a distance of 4,732.0 feet
6. The existing permitted point of diversion is located within the SE1/4 NW1/4 of Section 30, T.37N., R.40E., M.D.B.&M. or at a point from which the SE corner of said Section 30 bears S 33° 14' E a distance of 4,732.0 feet.
7. Proposed place of use 63.48 acres in Section 25, T.37N., R.39E., M.D.B.&M.
8. Existing place of use 38.35 acres in the NW1/4 NW1/4, 39.39 acres in the NE1/4 NW1/4, 39.00 acres in the SW1/4 NW1/4, 39.70 acres in the SE1/4 NW1/4, and 39.39 acres in the NW1/4 NE1/4, 38.26 acres in the NE1/4 NE1/4, 40.00 acres in the SW1/4 NE1/4, and 39.39 acres in the SE1/4 NE1/4, all within Section 30, T.37N, R.40E., M.D.B.&M., a total of 313.48 acres (63.48 acres to be removed).
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works install pipeline and an irrigation system
12. Estimated cost of works in excess of \$10,000
13. Estimated time required to construct works 3 years
14. Estimated time required to complete the application of water to beneficial use 5 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of a portion of the waters of an underground source as heretofore granted under Permit 26970, Certificate 8531 is issued subject to the terms and conditions imposed in said Permit 26970, Certificate 8531 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total acres irrigated under Permits 63014, 63015, 63016, 63017, 63018, 63019, 63020 and 63021 shall not exceed 581.72 acres within the described place of use.

The total combined duty of water under Permits 26484, Certificate 8529; 26968, Certificate 8530; 26970, Certificate 8531; 29042, Certificate 8575; 29043, Certificate 8576; 29044, Certificate 8577; 29045, Certificate 8578; 29046, Certificate 8579; 63014; 63015; 63016; 63017; 63018; 63019; 63020 and 63021 shall not exceed 7,360.0 acre-feet annually for the irrigation of 2,456.72 acres.

The issuance of this permit expires Permit 63040-T.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.094 cubic feet per second, **but not to exceed 190.44 acre-feet annually, and not to exceed a yearly duty of 3.0 acre-feet per acre of land irrigated from any and/or all sources.**


