The applicant FALLON PAIUTE-SHOSHONE TRIBE, hereby makes application for permission to change the Place of use of a portion of water heretofore appropriated under Final Decree in United States of America VS Orr Water Ditch Co. in Equity No. A 3, Claim No. 3, TCID Serial No. 712; Final Decree in United States of America VS. Alpine Land & Reservoir Co. Et Al., Civil No. D-183 BRT

1. The source of water is Truckee River and Carson River
2. The amount of water to be changed 315 acre-feet maximum subject to allocation
3. The water to be used for As Decreed
4. The water heretofore permitted for As Decreed
5. The water is to be diverted at the following point Lahontan Dam being within SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 33, T19N, R26E M.D.B.&M.
6. The existing permitted point of diversion is located within No Change
7. Proposed place of use 160 acres of which 90 acres to be irrigated; Farm Unit "N" Plot in the NE $\frac{1}{4}$, Section 27, T19N, R30E, M.D.B.&M.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the place of use of a portion of the waters of the Truckee and Carson Rivers as set forth under the Newlands Reclamation Project rights in the Truckee and Carson River final decrees is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on November 15, 1997 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 315.0 acre-feet as decreed.


