The applicant Steven R. Templeton, hereby makes application for permission to change the point of diversion, manner and place of use of a portion of water heretofore appropriated under permit No. 14145, certificate No. 4774

1. The source of water is underground
2. The amount of water to be changed .0129 cfs, 5.3 acre-feet
3. The water to be used for quasi-municipal
4. The water heretofore permitted for irrigation and domestic
5. The water is to be diverted at the following point SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 31, T.20S., R.60E. M.D.B.&M., or at a point from which the SW Corner of said section 31 bears South 76 degrees 07 minutes 40 seconds West a distance of 3,215.95 feet.
6. The existing permitted point of diversion is located within SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 18, T.21S., R.62E. M.D.B.&M., or at a point from which the SW Corner of said section 18 bears South 75 degrees 06 minutes 40 seconds West a distance of 1,580.8 feet.
7. Proposed place of use S $\frac{1}{2}$, S $\frac{1}{2}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 31 T.20S. R.60E. M.D.B.&M.
8. Existing place of use 1.06 acres within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of section 18 T.21S. R.62E. M.D.B.&M., see map detail. Specifically known as APN's 161-18-402-002, 161-18-402-003, 161-18-402-005 and 161-18-402-006.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works existing 8" drilled well to an underground distribution system.
12. Estimated cost of works \$80,000.00
13. Estimated time required to construct works 1 year
14. Estimated time required to complete the application of water to beneficial use 5 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 14145 Certificate 4774 is issued subject to the terms and conditions imposed in said Permit 14145 Certificate 4774 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.013 cubic feet per second, but not to exceed 5.3 acre-feet annually.
