The applicant Eugene H. Miller, hereby makes application for permission to change the Point of Diversion of a portion of water heretofore appropriated under Application 31540

1. The source of water is underground
2. The amount of water to be changed 2.7 c.f.s.
3. The water to be used for irrigation and domestic
4. The water heretofore permitted for irrigation and domestic
5. The water is to be diverted at the following point SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 24, T.1N., R.46E., M.D.B. & M. or at a point from which the SW Corner of said Section 24 bears S. 47° 33' 41" W., a distance of 4,023.2 feet
6. The existing permitted point of diversion is located within NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 24, T.1N., R.46E., M.D.B.&M., or at a point from which the SW Corner of said Section 24 bears S. 34° 08' W., a distance of 4,871 feet
7. Proposed place of use N $\frac{1}{2}$ Section 24, T.1N., R.46E., M.D.B.&M. - 320 acres
8. Existing place of use N $\frac{1}{2}$ Section 24, T.1N., R.46E., M.D.B.&M., - 320 acres
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works a drilled & cased well, equipped with a pump motor, and distribution system
12. Estimated cost of works \$50,000.00
13. Estimated time required to construct works 3 years
14. Estimated time required to complete the application of water to beneficial use 5 years
15. Remarks: Base right is currently in the name of Green Ridge Water Co. Documents are being filed to transfer title into applicant's name. Please utilities the map filed under Permit 31540 for the existing point of diversion and place of use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 31540 is issued subject to the terms and conditions imposed in said Permit 31540 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 63102 and 63103 shall not exceed 1,280.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued subject to the Amended Stipulation dated February 15, 1984, by Green Ridge Water Company and the State Engineer, Case No. 8694, in the District Court of the Fifth Judicial District of the State of Nevada, Nye County.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.7 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed

on or before:

December 16, 1999

Proof of completion of work shall be filed before:

January 16, 2000

Application of water to beneficial use shall be filed on or before:

December 16, 2002

Proof of the application of water to beneficial use shall be filed on or before:

January 16, 2003

Map in support of proof of beneficial use shall be filed on or before:

January 16, 2003
