The applicant KERRY LYNN HOLT hereby makes application for permission to change the PLACE OF USE of water heretofore appropriated under APPLICATION 59111

1. The source of water is Underground
2. The amount of water to be changed 240 Acre Feet 1.0740 c.f.s.
3. The water to be used for Irrigation
4. The water heretofore permitted for Irrigation
5. The water is to be diverted at the following point SE1/4 of the SE1/4 of Sec. 10, T5N, R66E, M.D.M., at a point, from which the Southeast Clorner of said Section bears S 02° 51' 17" E a distance of 773.86 feet. (Lincoln Co.)
6. The existing permitted point of diversion is located within the SE1/4 of the SE1/4 of Sec. 10, T5N, R66E, M.D.M., at a point from which the Southeast Corner of said Section 10 bears S 02° 28' 45" E a distance of 821.19 feet. (Lincoln Co.)
7. Proposed place of use the SE1/4 SE1/4 (40 Ac), and the SW1/4 SE1/4 (40 Ac), S1/2 NW1/4 SE1/4 (20 Ac) S1/2 NE1/4 SE1/4 (20 Ac.) All in Section 10, T5N, R66E, M.D.M.(Lincoln Co.)
8. Existing place of use SW1/4 SE1/4 (40.0 Ac.) SE1/4 SE1/4 (40.0 Ac.), all within Section 10, Township 5 North, Range 66 East, Mount Diablo Meridian (Lincoln Co.)
9. Use will be from January 1st to December 31st of each year.
10. Use was permitted from January 1st to December 31st of each year.
11. Description of proposed works Well drilled and cased to a depth sufficient to serve 1300 foot electrical rotaray pivot system
12. Estimated cost of works \$40,000.00 (Forty thousand dollars)
13. Estimated time required to construct works .Well completed. Drilled and cased with 12" casing - Equipped with 75 HP Electrical Motor --

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 59111 is issued subject to the terms and conditions imposed in said Permit 59111 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 63110 and 63340 shall not exceed 304.12 acre-feet annually for the irrigation of 76.03 acres within the described place of use.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.075 cubic feet per second, but not to exceed 240.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

May 17, 2000

Proof of completion of work shall be filed before:

June 17, 2000

Application of water to beneficial use shall be filed on or before:

May 17, 2001

Proof of the application of water to beneficial use shall be filed on or before:

June 17, 2001

Map in support of proof of beneficial use shall be filed on or before:

June 17, 2001
