The applicant Douglas County, a Political Subdivision of the State of Nevada, hereby makes application for permission to change the point of diversion, temporarily, of a portion of water heretofore appropriated under Permit No. 31076 (Certificate Record NO. 9716)

1. The source of water is Lake Tahoe
2. The amount of water to be changed .033 cfs not to exceed 1.0 million gallons annually
3. The water to be used for irrigation (landscaping and erosion control)
4. The water heretofore permitted for irrigation (landscaping and erpsion control)
5. The water is to be diverted at the following point within S $\frac{1}{2}$ Lot 1 (SE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 15, T.14N., R.18E., MDM, at a point from which the north one-quarter corner of said Section 15 bears N 26^o 26' 56" E, a distance of 1487.71 feet.
6. The existing permitted point of diversion is located within N $\frac{1}{2}$ Lot 1 (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 15, T.14N., R.18E., MDM at a point from which NE corner of said Section 15 bears N 84^o 35' E, a distance of 3770.0 feet.
7. Proposed place of use no change - see Item 8.
8. Existing place of use a total of approximatly 44 acres including portions of the N $\frac{1}{2}$ Lot 1, S $\frac{1}{2}$ Lot 1, NW $\frac{1}{4}$ NE $\frac{1}{4}$ and SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 15, T.14N., R.18E., MDM See attached map.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works 250 Ft. deep infiltration well.
12. Estimated cost of works \$50,000
13. Estimated time required to construct works four months
14. Estimated time required to complete the application of water to beneficial use one year

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion of a portion of the waters of Lake Tahoe heretofore granted under Permit 31076 Certificate 9716 is issued subject to the terms and conditions imposed in said Permit 31076 Certificate 9716 and with the understanding that no other rights at the source shall be affected by the change proposed herein. A totalizing meter must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to a beneficial use. This permit is subject to the final allocation of the State of Nevada under the California-Nevada Interstate Compact Commission. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 29160 Certificate 9714; 31076 Certificate 9716; 54376 Certificate 14467; 56325 Certificate 14460; 56648 Certificate 14461; 56649 Certificate 14462; 56780 Certificate 14468; 62107; 63205-T, and 63206-T shall not exceed 7.118 million gallons annually.

This temporary permit is issued with the understanding that the infiltration well shall be constructed in alluvial material which has a direct hydraulic connection to the surface waters of Lake Tahoe.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on August 24, 1998 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.033 cubic feet per second, but not to exceed 1.0 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

ATTACHMENT APPLICATION FOR TEMPORARY CHANGE
OF POINT OF DIVERSION

Item 15. Remarks

Douglas County owns and operates a public water supply system providing water service to individual residences within Uppaway, a planned unit development subdivision. Water is pumped from Lake Tahoe through a submerged intake pipeline and into a water distribution system consisting of pipelines and a steel tank storage reservoir. Withdrawal of Lake Tahoe water has been authorized under Permits No. 31076, 54376 and 56325. Permit No. 31076 (Certificate Record No. 9716) provides an appropriation of 5.657 million gallons annually. The other two permits provide additional appropriations to a total of 7.118 million gallons annually.

Douglas County proposes to modify the Uppaway water system, to provide for withdrawal of the appropriated Lake Tahoe surface water through infiltration wells proposed to be constructed adjacent to the Lake Tahoe shore line within the Uppaway common area. Two wells are proposed to be constructed in order to provide redundancy in operation of the water system. This application requests temporary changes of point of diversion for a portion of water appropriated under Permit No. 31076 to allow exploratory drilling for one of the infiltration wells and completion of a production well if exploratory drilling provides evidence that a production well can be developed. A second application is being submitted to provide for exploratory drilling and production well construction at the other well site.

If exploratory drilling provides evidence that production wells can be developed, applications will be submitted to change points of diversion to the proposed infiltration wells for all of the water rights used or proposed to be used through the Uppaway water supply system. The applications will also provide for change of place of use to correctly define the water service area and change of manner of use for all of the water rights to quasi-municipal.

It is requested that temporary change of point of diversion of a portion of water appropriated under Permit No. 31076 be granted for not less than six months from date of approval by the State Engineer.
