WATERS OF THE STATE OF NEVADA**

The applicant **Virgin Valley Water District**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **6.0** second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **domestic and quasi-municipal**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **NE $\frac{1}{4}$ SE $\frac{1}{4}$** of section 20, T13S, R70E, M.D.B.&M., at a point from which the SE corner of said Sec. 20 bears S 23° 30' 00" E, a distance of 1750 feet.
6. Place of Use All of T13S, R67E; T14S, R67E; T13S, R68E; T14S, R68E; T13S, R69E; T14S, R69E; T13S, R70E; T14S, R70E; T13S, R71E; and T14S, R71E; M.D.M. and portions of T15S, R69E; T15S, R70E; and T15S, R71E; M.D.M., Clark County, Nevada and Sec. 32, T40N, R16W, and Sec. 5, T39N, R16W, SRM, Mohave County, Arizona.
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drill deep well, install pump and motor, construct well house and transmission mains.**
9. Estimated cost of works **\$500,000.00**
10. Estimated time required to construct works **5 years**
11. Estimated time required to complete the application of water to beneficial use **6 years**
