The applicant DEEANN HOLT hereby make application for permission to change the POINT OF DIVERSION AN PLACE OF USE OF A PORTION of water heretofore appropriated under APPLICATION 22557 Book 24 Certificate 7555

1. The source of water is Underground
2. The amount of water to be changed 20.68 Acre Feet .0872 c.f.s.
3. The water to be used for Irrigation and Domestic
4. The water heretofore permitted for Irrigation and Domestic
5. The water is to be diverted at the following point within the NE1/4 of the NW1/4 of Sec. 10, T5N, R66E, M.D.M., at a point from which the North 1/4 Corner of said Section 10 bears N 00° 42' 42" E a distance of 970.25 feet. (Lincoln Co.)
6. The existing permitted point of diversion is located within the SE1/4 of the NW1/4 of Sec. 29, T6N, R66E, M.D.M., at a point from which the East 1/4 Corner of said Section 29 bears S 65° 19' 00" E a distance of 2,939.30 feet. (Lincoln Co.)
7. Proposed place of use the NE1/4 NW1/4 (31.30 ac.), and the SE1/4 NW1/4 (31.84 ac.), and the SW1/4 NW1/4 (31.07 ac.), and the NW1/4 NW1/4 (31.24 ac.) All within Section 10, T 5 N, R 66 E, M.D.M. (Lincoln Co.)
8. Existing place of use (5.17 Ac.) In the SW1/4 NW1/4 of Section 28, T 6 N, R 66 E, M.D.M. (Lincoln Co.)
9. Use will be from January 1st to December 31st of each year.
10. Use was permitted from January 1st to December 31st of each year.
11. Description of proposed works Well drilled and cased to a depth sufficient to serve 1300 foot electrical rotaray pivot system
12. Estimated cost of works \$40,000.00 (Forty thousand dollars)
13. Estimated time required to construct works .Well completed. Drilled and cased with 12" casing - Equipped with 75 HP Electrical Motor with Goulds Pump
14. Estimated time required to complete the application of water to beneficial use 1 Year

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 22557, Certificate 7555 is issued subject to the terms and conditions imposed in said Permit 22557, Certificate 7555 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 59113 and 63331 shall not exceed 500.68 acre-feet annually for the irrigation of 125.17 acres.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0872 cubic feet per second, **but not to exceed 20.68 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:

June 21, 2000

Proof of completion of work shall be filed before:

July 21, 2000

Application of water to beneficial use shall be filed on or before:

June 21, 2001

Proof of the application of water to beneficial use shall be filed on or before:

July 21, 2001

Map in support of proof of beneficial use shall be filed on or before:

July 21, 2001
