The applicant Virgin Valley Water District, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **6.0 second-feet**
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **domestic and quasi-municipal**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Sec. 25, T10S R68E, MDM, at a point from which the NE corner of said Sec. 25 bears S 25 $^{\circ}$ 31' 00" W a distance of 2500 feet.**
6. Place of Use **All of T13S R67E; T14S R67E; T13S R68E; T14S R68E; T13S R69E; T14S R69E; T13S R70E; R14S R70E; T13S R71E; and T14S R71E; MDM and portions of T15S R69E; T15S R70E; and T15S R71E; MDM, Clark County, Nevada and Sec. 32, T40N R16W, and Sec. 5 T39N R16W, SRM, Mohave County, Arizona.**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drill deep well, install pump and motor, construct well house and transmission mains.**
9. Estimated cost of works **\$500,000.00**
10. Estimated time required to construct works **5 years**
11. Estimated time required to complete the application of water to beneficial use **6 years**
12. Remarks: **For use in the Virgin Valley Water District service area to meet future expected demand due to population growth in the Mesquite and Bunkerville metropolitan area.**
