The applicant **Barker Homes, Inc.**, hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under portions of Claims 529, 530, 549, 565 and 576 of the Truckee River Decree, said Decree entered by the District Court of the United States for Nevada in that certain action entitled "The United States of America vs. Orr Water Ditch Company, et al., Defendants", in Equity Docket A-3.

1. The source of water is **Truckee River by Orr Ditch, as decreed**
2. The amount of water to be changed **19.59 afa and a prorata share of the diversion rate**
3. The water to be used for **As decreed**
4. The water heretofore permitted for **As decreed**
5. The water is to be diverted at the following point within the **NE¼ of the SW¼ of Section 17, T.19N., R.19E., M.D.M., or at a point from which the SW corner of said Section 17 bears South 44°40' West a distance of 3211 feet. For proposed point of diversion, this application, see existing point of diversion for Orr Ditch on map supporting Application No. 62513.**
6. The existing permitted point of diversion is located within the **SW¼ of the NE¼ of Section 7, T.19N., R.20E., M.D.M., or at a point from which the northeast corner of said Section 7 bears North 39°28' East a distance of 3015 feet. North Truckee Ditch per Orr Ditch Decree. See Map No. 59390 for existing point of diversion, this application.**
7. Proposed place of use within the **South half (S½) and Northeast quarter (NE¼) of Section 11, T.20N., R.20E., M.D.M.. See map supporting Application No. 62513.**
8. Existing place of use **See attached Exhibit "A". Also refer to map supporting Application No. 62897 filed March 7, 1997 in the Office of the Nevada State Engineer. (A total of 4.763 acres is being stripped by this application.)**
9. Use will be from **As Decreed to As Decreed** of each year.
10. Use was permitted from **As Decreed to As Decreed** of each year.
11. Description of proposed works **Works are existing.**
12. Estimated cost of works **None. Works are existing.**
13. Estimated time required to construct works **None. Works are existing.**
14. Estimated time required to complete the application of water to beneficial use **1 year**
