The applicant Allen G. and Brenda S. Nel, hereby make application for permission to change the Point of Diversion, Place and Manner of Use of water heretofore appropriated under Permit 62015

1. The source of water is Underground
2. The amount of water to be changed 0.275 CFS (100.0 Acre Feet/Year)
3. The water to be used for Recreation (Golf Course Irrigation) and Domestic
4. The water heretofore permitted for Recreation (Maintain Lake Level) and Domestic
5. The water is to be diverted at the following point within the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 31, T.20S., R.60E., MDM, whence the SW Corner of said Section 31 bears S. 76⁰ 07' 40" W. a distance of 3215.95 Feet
6. The existing permitted point of diversion is located within the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 8, T.21S., R.60E., MDM, or at a point whence the SW Corner of said Section 8 bears S. 43 12' 12" W. a distance of 3560.1 Feet.
7. Proposed place of use is 20.00 acres within the SW $\frac{1}{4}$, SE $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 31, and the SW $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 32, all within T 20S., R.60E., MDB&M.
8. Existing place of use is within 29.67 Acres located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, the SW $\frac{1}{4}$ NE $\frac{1}{4}$, the NE $\frac{1}{4}$ SW $\frac{1}{4}$, and the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 8, T.21S., R.60E., MDB&M. (The Lakes at West Sahara)
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works a drilled/cased well with pump, motor and meter at the well head, with pipelines/valves to the place of use.
12. Estimated cost of works \$250,000
13. Estimated time required to construct works 1 Year
14. Estimated time required to complete the application of water to beneficial use 3 Years
15. Remarks: The duty transferred under this permit will be commingled with the water from other permits to serve the Recreation (Golf Course Irrigation) needs of The Badlands Golf Course in the western Las Vegas Valley.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 62015 is issued subject to the terms and conditions imposed in said Permit 62015 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The issuance of Permit 63538 expires Permit 63545-T.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.275 cubic feet per second, but not to exceed 100.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:
