The applicant Wendy B. Ortiz, hereby make application for permission to change the Point of Diversion and Place of Use of water heretofore appropriated under Permit No. 60465

1. The source of water is an underground source
2. The amount of water to be changed 10.0 acre feet, 0.0389 cfs
3. The water to be used for irrigation and domestic purposes
4. The water heretofore permitted for irrigation and domestic purposes
5. The water is to be diverted at the following point within Government Lot 3 being a portion of the SE $\frac{1}{4}$  of Section 12, Township 17 South, Range 48 East, M.D.B.&M. at a point that bears North 03 $^{\circ}$  00' West 2500 feet from the Se corner of said Section 12.
6. The existing permitted point of diversion is located within the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  Section 15, Township 16 South, Range 48 East, M.D.B.&M. at a point from which the NW corner of said Section 15 bears North 58 $^{\circ}$  04' 42" West 429 feet.
7. Proposed place of use 2.5 Acres within 30 acres within Government Lot 3 being a portion of the SE $\frac{1}{4}$  Section 12, Township 17 South, Range 48 East, M.D.B.&M.
8. Existing place of use The NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 15, Township 16 South, Range 48 East, M.D.B.&M. strips 2.5 AC.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works Well, pump, pressure tank and distribution pipelines
12. Estimated cost of works 30,000
13. Estimated time required to construct works 2 years
14. Estimated time required to complete the application of water to beneficial use 5 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 60465 is issued subject to the terms and conditions imposed in said Permit 60465 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The issuance of this permit totally abrogates Permit 60465.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0389 cubic feet per second, but not to exceed 10.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

October 1, 2000

Proof of completion of work shall be filed before:

November 1, 2000

Application of water to beneficial use shall be filed on or before:

October 1, 2001

Proof of the application of water to beneficial use shall be filed on or before:

November 1, 2001

Map in support of proof of beneficial use shall be filed on or before:

November 1, 2001
