The applicant **REPUBLIC ENVIRONMENTAL TECHNOLOGIES, INC.**, hereby make application for permission to change the Point of Diversion of a portion of water heretofore appropriated under Permit 53322

1. The source of water is Underground, Garnet Valley
2. The amount of water to be changed 0.1004 CFS (27.5 AF/Year)
3. The water to be used for Industrial and Domestic
4. The water heretofore permitted for Industrial and Domestic
5. The water is to be diverted at the following point within the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 19, T.18S., R.64E., MDB, or at a point whence the North $\frac{1}{4}$ Corner of said Section 19 bears N. 57 23' W., a distance of 207.5 feet
6. The existing permitted point of diversion is located within the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 18, T.18S., R.64E., MDB&M, or at a point whence the NE Corner of said Section 18 bears N. 40 49' 36" E. a distance of 3008.5 Feet.
7. Proposed place of use is within portions of the SE $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, and SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 18, T.18S., R.64E., MDB&M, and portions of the NW $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ NW $\frac{1}{4}$, and SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 19, T.18S., R.64E., MDB&M, [Resurvey Tract 37, (Kelly Placer Mining Claim)]
8. Existing place of use Same as Proposed Place of Use
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works a drilled and cased well with pump, motor and meter at the well head, with pipelines and valves to the place of use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 53322 is issued subject to the terms and conditions imposed in said Permit 53322 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 53322, 59237, 60624, 63585, 63586, 63587, 63588, 63589, and 63590 shall not exceed 468.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1004 cubic feet per second, but not to exceed 27.5 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

October 8, 1999

Proof of completion of work shall be filed before:

November 8, 1999

Application of water to beneficial use shall be filed on or before:

October 8, 2000

Proof of the application of water to beneficial use shall be filed on or before:

November 8, 2000

Map in support of proof of beneficial use shall be filed on or before:
