The applicant **The Unincorporated Town of Pahrump**, hereby make application for permission to change the **Point of Diversion, Place of Use and Manner of Use of a portion** of water heretofore appropriated under **Permit #12560 Certificate 4857**

1. The source of water is **Underground source**
2. The amount of water to be changed **0.15 C.F.S.**
3. The water to be used for **irrigation and domestic (gm)**
4. The water heretofore permitted for **Irrigation and domestic (gm)**
5. The water is to be diverted at the following point **within the NE1/4 SW1/4 Section 32, T19S, R53E M.D.B. & M. or at a point from which the C1/4 corner of said Section 32 bears N25°07' E a distance of 793.0 feet.**
6. The existing permitted point of diversion is located within **NE1/4 SE1/4 Section 32 T19S, R53E, M.D.B. & M. or at a point from which the SE corner of said Sec. 32 bears S1°10' E a distance of 2590.0 feet**
7. Proposed place of use **a portion of NE1/4 SW1/4, Sec. 32 T19S, R53E M.D.B. & M., Unit 4, Rancho Del Sol, Block 2, Lot 5, 5 acres to be irrigated.**
8. Existing place of use **within the NE1/4 SE1/4 and the NW1/4 SE1/4, Sec. 32, T19S, R53 E M.D.B. & M. (15 acre feet to be removed) (1.5 acre feet per acre) 5.0 acres to be stripped from NW1/4 SE1/4 and 5.0 acres to be stripped from NE1/4 SE1/4**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **February 1 to October 31** of each year.
11. Description of proposed works **8" well casing thru plastic pipe to sprinklers.**
12. Estimated cost of works **20,000**
13. Estimated time required to construct works **3 years**
14. Estimated time required to complete the application of water to beneficial use **4 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 12560, Certificate 4857 is issued subject to the terms and conditions imposed in said Permit 12560, Certificate 4857 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

This permit is limited to the irrigation of 3.0 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.15 cubic feet per second, but not to exceed 15.0 acre-feet annually, and not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

March 3, 2001

Proof of completion of work shall be filed before:

April 3, 2001

Application of water to beneficial use shall be filed on or before:

March 3, 2004

Proof of the application of water to beneficial use shall be filed on or before:


