The applicant Red Creek Ranch, Inc., A Colorado Corporation hereby make application for permission to change the Point of Diversion and Place of Use of water heretofore appropriated under Permit 37029, Certificate 10569

1. The source of water is Underground
2. The amount of water to be changed 1.0 c.f.s., not to exceed 723.97 acre-feet annually.
3. The water to be used for Irrigation and Domestic.
4. The water heretofore permitted for Irrigation and Domestic
5. The water is to be diverted at the following point NE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 28, T.12N., R.23E., M.D.B.&M., or at a point from which the SW Corner of said Section 28 bears S. 19° 45' 00" W., a distance of 4,475.0 feet.
6. The existing permitted point of diversion is located within SE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 34, T.13N., R.23E., M.D.B.&M., or at a point from which the NW Corner of said Section 34 bears N. 45° 56' W. a distance of 1,930.0 feet.
7. Proposed place of use See Exhibit "A" Attached.
8. Existing place of use See Exhibit "B" Attached.
9. Use will be from January 1st to December 31st of each year.
10. Use was permitted from January 1st to December 31st of each year.
11. Description of proposed works A drilled and cased well, equipped with a Pump, Motor and Distribution System.
12. Estimated cost of works \$60,000.00.
13. Estimated time required to construct works Two (2) Years.
14. Estimated time required to complete the application of water to beneficial use Five (5) Years.



## Exhibit "C"

This application is being filed along with ten other applications to change the point of diversion and place of use of all or portions of Permits 6400, 6401, 6415, 7636, 7899, 11025, 37028, 37029, 37031 & 37032 (underground water rights) in Smith Valley, Nevada by Red Creek Ranch, Inc., a Colorado Corporation.

Said rights were previously owned by Trinox Company but were conveyed to Pruett Ranches, Inc. Documentation updating the chain of title to the applicant has been submitted to the State Engineer's office.

The water rights being transferred by these applications are not intended to be supplemental to any surface water rights from the West Walker River which may be appurtenant to the proposed place of use.

The total combined duty of this application and any other application being filed to change Permits 37031 and 37032 shall not exceed 957.6 acre-feet annually.

The total combined duty of this application and any other application being filed to change all or portions of Permits 6400, 6401, 6415, 7636, 7899, 11025, 37028, 37029, 37031 & 37032 shall not exceed 2,326.28 acre-feet annually.
