The applicant **Winnemucca Farms, Inc.**, hereby makes application for permission to change the **manner of use, place of use, and point of diversion of a portion** of water heretofore appropriated under **Permit 27449 Certificate 9792**

\*\*\*\*\*

1. The source of water is **underground**
2. The amount of water to be changed **0.17 cfs**
3. The water to be used for **industrial effluent dilution and domestic purposes**
4. The water heretofore permitted for **industrial and domestic purposes**
5. The water is to be diverted at the following point **within the SW¼ NW¼ of Section 6, T.35N., R.38E., MDB&M or at a point from which the W¼ corner of said Section 6 bears S 20°55'46" W a distance of 1,511.0 feet**
6. The existing permitted point of diversion is located within **the NE¼ SW¼ of Section 31, T.36N., R.38E., MDB&M or at a point from which the NW corner of Section 6, T.35N., R.38E., MDB&M bears S 53°01'40" W a distance of 2,709.9 feet**
7. Proposed place of use **a portion of the NW¼ of Section 6, T.35N., R.38E., MDB&M and a portion of the S½ and the NE¼ of Section 1, T.35N., R.37E., MDB&M**
8. Existing place of use **within the W¼ of Section 31, T.36N., R.38E. MDB&M**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **a drilled well and pipelines to storage ponds and spray field**
12. Estimated cost of works **\$60,000**
13. Estimated time required to construct works **1 year**
14. Estimated time required to complete the application of water to beneficial use **2 years**

15. Remarks: The existing place of use and point of diversion are shown on the map supporting Application 27449. Water is to be mixed with the process water from the Winnemucca Farms potato processing plant in order to meet state requirements for land application of process water and to ensure proper and efficient functioning of the integrated water handling and treatment. APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 27449, Certificate 9792, is issued subject to the terms and conditions imposed in said Permit 27449, Certificate 9792, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from the wells under Permit 26633, Certificate 8908; Permit 27449, Certificate 9792; Permit 27685, Certificate 10445; Permit 33997, Certificate 9596; and Temporary Permits 64118-T and 64119-T. These records shall be submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **October 9, 2002** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.17 cubic feet per second, but not to exceed 40.5 million gallons annually.
