The applicant **Neil G. & Elaine Galatz**, hereby make application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit 51864, Certificate 12475**

1. The source of water is **Underground, Clark County**
2. The amount of water to be changed **0.01 CFS (6.0 AF/Year)**
3. The water to be used for **Irrigation and Domestic**
4. The water heretofore permitted for **Irrigation and Domestic**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 51864, Certificate 12475 is issued subject to the terms and conditions imposed in said Permit 51864, Certificate 12475 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 64140, 64141, 64142, 64143, 64144, 64145, 64146 and 64147 shall not exceed 82.6 acre-feet annually for the irrigation of 15.21 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.01 cubic feet per second, **but not to exceed 6.0 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

March 30, 2000

Proof of completion of work shall be filed before:

April 30, 2000

Application of water to beneficial use shall be filed on or before:

March 30, 2001

Proof of the application of water to beneficial use shall be filed on or before:





The purpose of this Application to Change is twofold:

1. The Place of Use is changed so that the Water from Permit 51864 can be intermixed and co-mingled with the duty from seven (7) other Permits applicable to the land owned by the permittee. The pipelines from the Point of Diversion for this Permit will be interconnected with the pipelines from the three (3) other wells on the property. This co-mingling will allow the permittee flexibility in his irrigation procedures and will allow him to more efficiently utilize the duty from all his permits.
2. The Point of Diversion is moved to make use of a well already existing on property recently purchased by the permittee.


