The applicant JELINDO A TIBERTI II AND SANDEE MELVIN TIBERTI, hereby make application for permission to change the POINT OF DIVERSION, MANNER OF USE, AND PLACE OF USE OF A PORTION of water heretofore appropriated under PERMIT NO. 61403

1. The source of water is UNDERGROUND
2. The amount of water to be changed 0.4 ACRE-FEET, 0.0057 CFS
3. The water to be used for COMMERCIAL
4. The water heretofore permitted for IRRIGATION

7. Proposed place of use SW $\frac{1}{2}$  SECTION 2, T20S, R53E, MDB&M, OR PARCEL 123 OF SURVEY MAP FILE #84280, RECORDS OF NYE COUNTY, NV

9. Use will be from JAN 1 to DEC 31 of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use, and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 61403 is issued subject to the terms and conditions imposed in said Permit 61403 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.001 cubic feet per second, **but not to exceed 0.40 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

March 9, 2001

Proof of completion of work shall be filed before:

April 9, 2001

Water must be placed to beneficial use on or before:

March 9, 2003

Proof of the application of water to beneficial use shall be filed on or before:

April 9, 2003

Map in support of proof of beneficial use shall be filed on or before:


