The applicant Edward J. Hayes & Constance G. Hayes, hereby make application for permission to change the Point of Diversion and Place of Use of water heretofore appropriated under all of Permit No. 53676

1. The source of water is underground
2. The amount of water to be changed 0.02858 cfs, 4.0 acre feet annually
3. The water to be used for Irrigation and Domestic
4. The water heretofore permitted for Irrigation and Domestic
5. The water is to be diverted at the following point within the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 9, T.22N., R.21E., M.D.M., or at a point from which the northeast corner of said Section 9 bears North 64° 50' East a distance of 2940 feet. See map accompanying Application No. 63064.
6. The existing permitted point of diversion is located within the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 25, T.22N., R.20E., M.D.M., or at a point from which the southeast corner of said Section 25 bears South 10° 07' 27" East a distance of 1202.1 feet. See map accompanying Application Nos. 53676 & 54412.
7. Proposed place of use within the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 9, T.22N., R.21E., M.D.M.. (1.0 acre, the exact location to be determined later.) See map accompanying Application No. 63064.
8. Existing place of use 1.0 acre within the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 25, T.22N., R.20E., M.D.M.. See map accompanying Application Nos. 53676 & 54412.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works Drilled well, pump and distribution system.
12. Estimated cost of works \$50,000.00
13. Estimated time required to construct works 3 years
14. Estimated time required to complete the application of water to beneficial use 5 years
15. Remarks: This application changes the point of diversion and place of use of all of Permit No. 53676 to property owned by Edward and Constance Hayes.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 53676 is issued subject to the terms and conditions imposed in said Permit 53676 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 63064, 63065, 63072, 63074, 63222, 63223, 63455, 63456, 63708, 64265, 64266, 64267, 64268, 64269 and 64270 shall not exceed 151.0 acre-feet annually for the irrigation of 37.75 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.02858 cubic feet per second, but not to exceed 4.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.
