The applicant Robert D. and Luella R. WATROUS TRUSTEES of the WATROUS FAMILY TRUST Dated August 9, 1988, hereby makes application for permission to change the Point of Diversion and Place of Use of a Portion of water heretofore appropriated under Proof 01349 & 01350 Barber Creek Decree Dated May 27, 1927 - Eugene Scossa, Contestant vs. Clarissa Church and Barber Estate Contestees.

1. The source of water is **BARBER CREEK**
2. The amount of water to be changed **6 A.F.A. (per season)**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **SW¹/₄ SW¹/₄ Section 14, T.12N., R.19E., M.D.B.&M. or at a point from which the SW corner of said Section 14 bears S. 03° 34' 32" W., a distance of 781.57 feet.**
6. The existing permitted point of diversion is located within **BARBER CREEK DECREE**
7. Proposed place of use **Portions of the NW¹/₄ SW¹/₄ and SW¹/₄ SW¹/₄ Section 14, T.12N., R.19E., M.D.B.&M. Reference APN 19-191-02 and 19-191-27, 1.632 Acres Total (Attached)**
8. Existing place of use **5.0 Ac. within NW¹/₄ SW¹/₄; 0.5 Ac. within SW¹/₄ SW¹/₄; 29.35 Ac. within SE¹/₄ SW¹/₄; 15.92 Ac. within NW¹/₄ SE¹/₄; 27.91 Ac. within SW¹/₄ SE¹/₄ and 1.38 Ac. within SE¹/₄ SE¹/₄ all within Section 14, T.12N., R.19E., M.D.B.&M.**
9. Use will be from **April 1st to October 1st** of each year.
10. Use was permitted from **April 1st to October 1st** of each year.
11. Description of proposed works **Diversion box, sand collection box and diversion system has been completed.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of Barber Creek, as heretofore appropriated under Proofs 01349 and 01350 as appears in the Matter of the Determination of the Relative Rights to Waters of Barber Creek and its Tributaries, in the District Court of the First Judicial District of the State of Nevada, in and for the County of Douglas is issued subject to the terms, conditions and irrigation period imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

A valve or other type of regulating device with a substantial measuring device must be installed at the applicants' point of diversion to ensure that the total quantity of water diverted is limited to the amount permitted.

A substantial measuring device must be placed above the uppermost diversion on Barber Creek. This measuring device must be approved by the State Engineer prior to installation and prior to any diversion of water.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0166 cubic feet per second, but not to exceed 6.0 acre-feet per season.

Work must be prosecuted with reasonable diligence and be completed on or before:

March 29, 2001

Proof of completion of work shall be filed before:

April 29, 2001

Water must be placed to beneficial use on or before:

March 29, 2003

Proof of the application of water to beneficial use shall be filed on or before:

April 29, 2003

Map in support of proof of beneficial use shall be filed on or before:


