The applicant **Greg L. and Kathleen J. Casey**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **.26 cfs** second-feet
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **quasi-municipal**
4. If use is for:
  - (a) Irrigation, state number of acres to be irrigated
  - (b) Stockwater, state number and kinds of animals to be watered
  - (c) Other use (describe fully under No. 12. "Remarks")
  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **NW¼ SE¼** of Section 29, T.19S R60E or at a point from which the center quarter corner (C¼) bears N. 41°41'16" W. a distance of 1270.33 feet. Refer to map filed under cancelled Permit #53900.
6. Place of Use a portion of the **N¼ SE¼ NW¼ SE¼** of Section 29, Township 19 South, Range 60 East, M.D.M., Clark County, Nevada. Refer to map filed under cancelled Permit #53900.
7. Use will begin about **Jan 1** and end about **Dec 31**, of each year.
8. Description of proposed works **8" drilled well two (2) storage tanks to an underground distribution system**
9. Estimated cost of works **\$25,00000**
10. Estimated time required to construct works **1 year**
11. Estimated time required to complete the application of water to beneficial use **2 years**
12. Remarks: **This application is being filed under the exemption outlined in Amended Order 1054 to reinstate 5 five homes previously permitted under cancelled Permit No. 53900 Please refer to map filed under cancelled Permit #53900.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permit 64413 is issued to provide water service to five lots described by Clark County Assessor Parcel Numbers (APN) 125-29-706-002, 125-29-706-004, 125-29-706-006, 125-29-706-007 and 125-29-706-008.

This permit is issued subject to the State Engineer's Amended Order 1054 dated April 15, 1992.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.26 cubic feet per second, but not to exceed 1.825 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

February 12, 2001

Proof of completion of work shall be filed before:

March 12, 2001

Application of water to beneficial use shall be filed on or before:

February 12, 2004

Proof of the application of water to beneficial use shall be filed on or before:

March 12, 2004


