The applicant DOUGLAS COUNTY, hereby makes application for permission to change the PLACE OF USE AND POINT OF DIVERSION of water heretofore appropriated under PERMIT 42780

1. The source of water is AN UNDERGROUND SOURCE
2. The amount of water to be changed 2.0 cfs (100.00 mga)
3. The water to be used for QUASI-MUNICIPAL & DOMESTIC
4. The water heretofore permitted for QUASI-MUNICIPAL & DOMESTIC (NO CHANGE)

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 42780 is issued subject to the terms and conditions imposed in said Permit 42780 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 64427 and 64428 shall not exceed 100.0 million gallons annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, **but not to exceed 100.0 million gallons annually.**



## EXHIBIT "B"

Permit 42780

Permit 42780 is within the Omohundro well and is part of the East Valley Water System Service Area. An Application to Change is being filed to move the water rights under this permit into the Main Airport well, and to change the Place of Use to the New East Valley Service Area.

Douglas County has Bonded for \$3,000,000 in System Improvements, which includes a new well, booster pump station, water tank and piping. These improvements are currently under construction and are scheduled to be completed in the Fall of 1998. The Water System will be divided into three (3) Pressure Zones, each zone with storage. County Staff is currently preparing a water system demand study to document current and future water needs.

To allow time for the State to act on this Change Application, Douglas County respectfully requests that an extension of time be granted for a period of One (1) year.
