The applicant U.S. Department of Energy Yucca Mountain Site Characterization Project, hereby makes application for permission to change the point of diversion and place of use of a portion of water heretofore appropriated under Permit 57373

1. The source of water is **Underground**
2. The amount of water to be changed **0.333 cfs (19 af)**
3. The water to be used for **Industrial/Pump Test**
4. The water heretofore permitted for **Industrial**
5. The water is to be diverted at the following point **MDB&M T.12S., R.49E., S.35 SE 1/4 SE 1/4 (unsurveyed) GPS Coordinates; Longitude W 116°28'02" Latitude N 36°50'40" Altitude 1495.24 meters**
6. The existing permitted point of diversion is located within **SW 1/4 NE 1/4, Sec. 6, T.14S., R.50E., MDB&M** or at a point from which the SW corner of said Sec. 6 bears **S51°08'04"W** a distance of **4332.31 feet**
7. Proposed place of use **MDB&M T.12S., R.49E., S.35 SE 1/4 SE 1/4 (unsurveyed) GPS Coordinates: Longitude W 116°28'02" Latitude N 36°50'40" Altitude 1495.24 meters**
8. Existing place of use **Refer to Attachment "A"**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **A drilled well equipped with a motor, pump, pipeline and standpipe.**
12. Estimated cost of works **\$1 million to mobilize, drill and conduct testing**
13. Estimated time required to construct works **Four months**
14. Estimated time required to complete the application of water to beneficial use **one (1) year**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the place of use and point of diversion of a portion of Permit 57373 of the waters of an underground source as heretofore granted under Permit 57373 is issued subject to the terms and conditions imposed in said Permit 57373 and with the understanding that no other rights on the source will be affected by the change proposed herein.

It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept for water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit is issued subject to: (1) Compliance with the monitoring program titled "Monitoring Program for the Groundwater Levels and Spring Flows in the Yucca Mountain Region of Southern Nevada and California, February 1991, United States Department of Energy, Yucca Mountain Project Office"; (2) data collected from said monitoring program shall be submitted to the State Engineer's office on a quarterly basis, within thirty (30) days after the end of each calendar quarter, and (3) the terms and conditions set forth in State Engineer's Ruling No. 3870, dated March 2, 1992.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within fifteen (15) days after the end of each calendar quarter.

The total combined duty of water under Permits 57373, 57374, 57375, 57376, 58827, 58828, 58829 and 64451-T shall not exceed 430.19 acre feet annually.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on January 11, 2000 at which time all rights herein granted shall revert to the water right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.333 cubic feet per second, but not to exceed 19.0 acre-feet annually.



ATTACHMENT "B"

This application is being refiled in order to extend Temporary Permit 63384T to temporarily use water appropriated under Permit 57373 (Well J-12) for a pump test at borehole USW SD-6. The pump test is being performed in conjunction with site characterization activities for the Yucca Mountain Project (YMP). The planned test activity at USW SD-6 consists of road and pad construction, drilling, perched-water testing and monitoring, geophysical logging, confirmation of lithology, and sampling. At total depth, the borehole will be pumped clean to verify connection to the aquifer and saturated zone tests will be conducted. The pump test will be approximately three months in duration and is expected to be completed within one year.

Under Permit 57373, the YMP has appropriated 430.19 acre-feet (af). The total consumptive duty of this application will not exceed 19 af. The water will be released into Solitario Canyon through a pipeline and distribution tank.

All terms and conditions applicable to Permit 57373 will also be observed on this Permit.

The well designation is J-12.

For the Proposed Place of Use, refer to the attached map. For the Existing Point of Diversion and Existing Place of Use, refer to the map filed under Permit 57373.
