The applicant Lincoln County and Vidler Water Company, Inc., hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground
2. The amount of water applied for is 10.0 c.f.s. second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for Irrigation
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated 1280 acres
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 11, T.4N., R.66E., MDM, or at a point from which the S $\frac{1}{4}$ corner of Section 35, T.5N., R.66E., MDM, bears North 00^o 04' West, a distance of 6330 feet. Located within Patterson Wash.
6. Place of Use Within Section 11, W $\frac{1}{2}$ Section 12, W $\frac{1}{2}$ Section 14, W $\frac{1}{2}$ Section 23, T.4N., R.66E., MDM. Irrigation will be limited to 1280 acres within the proposed Place of Use.
7. Use will begin about January 1 and end about December 31 of each year.
8. Description of proposed works drilled well, pump and motor, and irrigation distribution system
9. Estimated cost of works \$100,000
10. Estimated time required to construct works 5 years
11. Estimated time required to complete the application of water to beneficial use 10 years
12. Remarks: The land within the Place of Use is proposed to be acquired through a land exchange with the Bureau of Land Management.
