The applicant Lincoln County and Vidler Water Company, Inc., hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground**
2. The amount of water applied for is **10.0 c.f.s. second-feet**

3. The water to be used for **Irrigation**

The water is to be diverted from its source at the following point On unsurveyed ground within the **SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 31, T.1S., R.62E., MDM., or at a point from which the S $\frac{1}{4}$ corner of Section 34, T.1N., R.62E., MDM, bears North 28^o 58' East, a distance of 35,511 feet. Located within Pahroc Valley.**
6. Place of Use On unsurveyed ground within the **SE $\frac{1}{4}$ Section 31, W $\frac{1}{2}$ Section 32, T.1S., R.62E., N $\frac{1}{2}$, SW $\frac{1}{4}$ Section 6, NW $\frac{1}{4}$ Section 7, T.2S., R.62E., E $\frac{1}{2}$ Section 12, N $\frac{1}{2}$ SW $\frac{1}{4}$ Section 13, NW $\frac{1}{4}$ Section 24, T.2S., R.61E., MDM. Irrigation will be limited to 1280 acres within the proposed Place of Use.**
7. Use will begin about January 1 and end about December 31, of each year.
8. Description of proposed works drilled well, pump and motor, and irrigation distribution system
