The applicant South Truckee Meadows General Improvement District, c/o Washoe County, hereby makes application for permission to change the Point of Diversion and Manner of Use of a portion of water heretofore appropriated under Permit 48580

1. The source of water is Underground
2. The amount of water to be changed 0.2836cfs, but not to exceed 27.6MGA
3. The water to be used for Municipal
4. The water heretofore permitted for Quasi-Municipal and Domestic
5. The water is to be diverted at the following point SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 22, T.18N., R.19E., M.D.B.&M., or at a point from which the SE corner of Section 23, T.18N., R.19E., M.D.B.&M., bears S. 60° 50' 09" E., a distance Of 6,212.87 feet.
6. The existing permitted point of diversion is located within NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 28, T.18N., R.20E., M.D.B.&M., or at a point from which the E $\frac{1}{4}$ corner of said Section 28 bears S. 26° 10' 30" E., a distance of 2,003.18 feet.

8. Existing place of use Please see attached Exhibit "A"
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works Well, pump, and motor to a storage tank and distribution system.
12. Estimated cost of works \$600,000.00
13. Estimated time required to construct works 5 years
14. Estimated time required to complete the application of water to beneficial use 10 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 48580 is issued subject to the terms and conditions imposed in said Permit 48580 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030.

The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is issued subject to existing rights. It is This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 30261, 48569, 48571, 48572, 48574, 48575, 48581, 48584, 48585, 48586, 49470, 51803, 51804, 51805, 51806, 51947, 51948, 52426, 52507, 52862, 54283, 57159, 57160, 57161, 57213, 57334, 57335, 57410, 57411, 57412, 57413, 57414, 57415, 57416, 58325, 58326, 58929, 58930, 59331, 59791, 59792, 61189, 61332, 61333, 61466, 61914, 61977, 61999, 62036, 62237, 62535, 62859, 63004, 63254, 63255, 63406, 63495, 63603, 64293, 64294, 64376, 64508, 64543, 64837, 64838, and 65111 shall not exceed 1,585.83 million gallons annually.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2836 cubic feet per second, **but not to exceed 27.6 million gallons annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

Proof of completion of work shall be filed before:

May 11, 2001

Water must be placed to beneficial use on or before:

April 11, 2002

Proof of the application of water to beneficial use shall be filed on or before:

May 11, 2002

Map in support of proof of beneficial use shall be filed on or before:


