The applicant Charles E. Ellison, Ann F. Ellison James F. Ellison & Joyce Ellison, hereby makes application for permission to change the Place of Use of water heretofore appropriated under Application 59813

1. The source of water is Underground.
2. The amount of water to be changed 0.15 cfs
3. The water to be used for Quasi-Municipal
4. The water heretofore permitted for Quasi-Municipal
5. The water is to be diverted at the following point SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 10, T.35N., R.56E. or at a point from which the W $\frac{1}{4}$ corner of said Section 10, bears S.72 $^{\circ}$ 55' 15" W. a distance of 1510.83 feet. (use map filed under 59813)
6. The existing permitted point of diversion is located within SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 10, T.35N., R.56E., M.D.B.&M. or at a point from which the W $\frac{1}{4}$ corner of Section 10 bears S. 72 $^{\circ}$ 55'15" W. a distance of 1510.83 feet.
7. Proposed place of use NE $\frac{1}{4}$ NW $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 10, T35N., R.56E., M.D.B.&M (13.72 acres total) (use map filed under 59813)
8. Existing place of use SW $\frac{1}{4}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 10, T.35N., R.56E., M.D.B.&M. (3.72 ac)
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works water to be pumped into a 1000 gallon storage tank.
12. Estimated cost of works \$6,000.00
13. Estimated time required to construct works 1 year
14. Estimated time required to complete the application of water to beneficial use 2 years
15. Remarks: Well will be used for a 30-unit Mobile Home/R.V. Park, laundry mat and office, & fire system.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 59813 is issued subject to the terms and conditions imposed in said Permit 59813 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 53224, Certificate 13399; 59815, 64868 and 64869 shall not exceed 6.20 million gallons annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.15 cubic feet per second, but not to exceed 3.65 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

August 31, 2000

Proof of completion of work shall be filed before:

September 30, 2000

Water must be placed to beneficial use on or before:

August 31, 2002

Proof of the application of water to beneficial use shall be filed on or before:

September 30, 2002


