The applicant **Ramparts, Inc.**, hereby make application for permission to change the **Point of Diversion, Place of Use** of water heretofore appropriated under **Permit 63260**

1. The source of water is **Underground**
2. The amount of water to be changed **0.20 cfs, not to exceed 12.37 acre feet annually**
3. The water to be used for **Commercial and Domestic**
4. The water heretofore permitted for **Commercial and Domestic**
5. The water is to be diverted at the following point **NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 29, T21S, R61E, MDM, or at a point from which the center of said Section 29 bears N 86° 50' 50" W, a distance of 1299.67 feet.**
6. The existing permitted point of diversion is located within **SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 29, T21S, R61E, MDM or at a point from which the East $\frac{1}{4}$ corner of said Section 29 bears S 58° 33' 28" E, a distance of 1875.48 feet.**
7. Proposed place of use **Portions of NW $\frac{1}{4}$ SE $\frac{1}{4}$ and NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 29, T21S, R61E, MDM.**
8. Existing place of use **SE $\frac{1}{4}$ NE $\frac{1}{4}$ and portion of SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 29, T21S, R61E, MDM.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **well pump & motor was installed under Permit 25324. A new meter and pipe line and water tank to be installed**
12. Estimated cost of works **to complete project \$100,000**
13. Estimated time required to construct works **completed except for meter**
14. Estimated time required to complete the application of water to beneficial use **5 years**
15. Remarks: **The well is located in a room off the electric substation on the north side of the theater in the Mandalay Bay Hotel Casino. Water is pumped through a piping system to a tank and then to the water feature, landscaped areas, and cooling towers. The total combined use from the three applications shall not exceed 11.643 million gallons per annum.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 63260 is issued subject to the terms and conditions imposed in said Permit 63260 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on June 8, 2000 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.20 cubic feet per second, but not to exceed 12.37 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:
