The applicant Robert C. Hale, hereby makes application for permission to change the Point of Diversion and Place of Use of a portion of water heretofore appropriated under Application No. 31538

1. The source of water is Underground.
2. The amount of water to be changed 2.7 c.f.s..
3. The water to be used for Irrigation and Domestic.
4. The water heretofore permitted for Irrigation and Domestic.
5. The water is to be diverted at the following point NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 11, T1N, R46E, MDM, or at a point from which the SE corner of Section 2 T1N, R46E, MDM, bears N 79 $^{\circ}$ 44' 26" E, a distance of 1651.47 feet.
6. The existing permitted point of diversion is located within NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 28, T1N, R46E, MDM, or at a point from which the NE corner of said Section 28, Bears N 64 $^{\circ}$ 04' E, a distance of 2893.00 feet
7. Proposed place of use NW $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$ and NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 11 T1N, R46E, MDM.
8. Existing place of use N $\frac{1}{2}$ Section 28 T1N, R46E, MDM.
9. Use will be from January 1, to December 31, of each year.
10. Use was permitted from January 1, to December 31, of each year.
11. Description of proposed works well and pump sprinkler system.
12. Estimated cost of works \$25,000.00
13. Estimated time required to construct works 3 years
14. Estimated time required to complete the application of water to beneficial use 5 years.
