

1. The source of water is Underground.
2. The amount of water to be changed 2.7 c.f.s..
3. The water to be used for Irrigation and Domestic.
4. The water heretofore permitted for Irrigation and Domestic.
5. The water is to be diverted at the following point SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 12, T1N, R46E, MDM, or at a point from which the West quarter-corner of Section 14, T.1N., R.46E., M.D.B.&M., bears S 62 $^{\circ}$ 33' 56" W, a distance of 6336.24 feet.


