

The applicant Gary J. Fredrickson, hereby makes application for permission to change the Point of Diversion and Place of Use of a portion of water heretofore appropriated under Application No. 31545

1. The source of water is Underground.
2. The amount of water to be changed 2.7 c.f.s..
3. The water to be used for Irrigation and Domestic.
4. The water heretofore permitted for Irrigation and Domestic.
5. The water is to be diverted at the following point SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 22 T1N, R46E, MDM, or at a point from which the SW corner of Section 24, T.1N., R.46E., M.D.B.&M bears S 61 $^{\circ}$ 52' 42" E, a distance of 6313.28 feet.
6. The existing permitted point of diversion is located within NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 26, T1N, R46E, MDM, or at a point from which the NE corner of said Section 26, Bears N 33 $^{\circ}$ 55' E, a distance of 4698.00 feet
7. Proposed place of use NE $\frac{1}{4}$ of Section 22 T1N, R46E, MDM
8. Existing place of use S $\frac{1}{2}$ of Section 26 T1N, R46E, MDM.
9. Use will be from January 1, to December 31, of each year.
10. Use was permitted from January 1, to December 31, of each year.
