The applicant E-T-T Enterprises, L.L.C., hereby makes application for permission to change the point of diversion, manner of use and place of use of a portion of water heretofore appropriated under Permit 14261; Certificate 5328

1. The source of water is underground
2. The amount of water to be changed 0.053 cfs and 25.0 afa
3. The water to be used for commercial and domestic
4. The water heretofore permitted for irrigation and domestic
5. The water is to be diverted at the following point SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 12, Township 21 South, Range 53 East, MDB&M, Nye County, Nevada, from which the Southeast corner of said Section 12 bears south 29° 20' 58" East, a distance of 550.28 feet.
6. The existing permitted point of diversion is located within SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 33, Township 19 South, Range 53 East, MDB&M, Nye County, Nevada, at a point from which the S.E. corner of said Section 33 bears South 0° 45' East, 3,000 feet.
7. Proposed place of use Portion of SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 12, Township 21 South, Range 53 East, MDB&M, Nye County, Nevada, as set forth on accompanying map.
8. Existing place of use Portion of S $\frac{1}{2}$ NE $\frac{1}{4}$ Section 33, and S $\frac{1}{2}$ NW $\frac{1}{4}$ Section 34, Township 19 South, Range 53 East, MDB&M, Nye County, Nevada, 35.322 acres within SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 33, Township 19 South, Range 53 East, MDB&M, Nye County, Nevada to be removed from irrigation, 3.664 acres within SE $\frac{1}{2}$ NE $\frac{1}{4}$ of the same Section 33 to be removed from irrigation.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from March 1 to November 1 of each year.
11. Description of proposed works well, pump and appurtenances
12. Estimated cost of works \$100,000.00
13. Estimated time required to construct works 3 years, pump house and water tank are existing
14. Estimated time required to complete the application of water to beneficial use 5 years

15. Remarks: For use with Lake and various water features at Casino operation.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use, and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 14261, Certificate 5328 is issued subject to the terms and conditions imposed in said Permit 14261, Certificate 5328 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The total combined duty of water under Permits 65086, 65088, 65731, 65732, and 65733 shall not exceed 131.0 acre-feet annually.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0525 cubic feet per second, **but not to exceed 25.0 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

July 20, 2002

Proof of completion of work shall be filed before:

August 20, 2002

Water must be placed to beneficial use on or before:

July 20, 2005

Proof of the application of water to beneficial use shall be filed on or before:

August 20, 2005

Map in support of proof of beneficial use shall be filed on or before:
