The applicant Washoe County, a political subdivision of the State of Nevada, hereby makes application for permission to change the point of diversion, place of use and manner of use of a portion of water heretofore appropriated under Claim #88 and 88a of the Truckee River Decree, said decree entered in the District Court of the United States for Nevada in that certain action entitled "The United States of America, Plaintiff, vs. Orr Water Ditch Company, et al., Defendants, " in equity Docket No. A-3.

1. The source of water is Truckee River
2. The amount of water to be changed 0.958 CFS not to exceed 177.84 acre feet annually
3. The water to be used for Municipal
4. The water heretofore permitted for as decreed
5. The water is to be diverted at the following point See Exhibit "A" attached hereto and map supporting application #58882 on file with the State Engineer.
6. The existing permitted point of diversion is located within NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 31, T.19N., R.18E., M.D.B.&M. or at a point from which the Southeast corner of said Section 31 bears S. 62° 04' E. a distance of 3195.00 feet (Steamboat Canal).

8. Existing place of use Section 20, T.18N., R.20E., M.D.B.&M. NW $\frac{1}{4}$ SE $\frac{1}{4}$ -- 25.97 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$ -- 0.13 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$ -- 18.36 acres TOTAL - 44.46 acres
9. Use will be from January 1 to December 31 of each year.

11. Description of proposed works Water will be diverted by S.P.P.Co. facilities, treated and placed into distribution systems of S.P.P.Co. & Washoe County.

STEAMBOAT CANAL (HUNTER CREEK RESERVOIR):

The existing point of diversion is situated within the Northeast one-quarter of the Southwest one-quarter (NE1/4 SW1/4) of Section 31, T.19N., R.18E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 31 bears South 62°04' East, a distance of 3,195.00 feet.

HIGHLAND DITCH (HIGHLAND RESERVOIR):

The existing point of diversion is situated within the Southwest one-quarter of the Southeast one-quarter (SW1/4 SE1/4) of Section 9, T.19N., R.18E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 9 bears South 75°16' East, a distance of 1,650.00 feet.

IDLEWILD TREATMENT PLANT:
