The applicant Dangberg Holdings Nevada, LLC, hereby makes application for permission to change the Point of Diversion of water heretofore appropriated under Permit 44684

1. The source of water is seeps and springs
2. The amount of water to be changed 1.0 CFS
3. The water to be used for irrigation and domestic (no change)
4. The water heretofore permitted for irrigation and domestic
5. The water is to be diverted at the following point within the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 16, T13N, R20E, MDB&M or at a point from which the E $\frac{1}{4}$ corner of Section 21, T13N, R20E, MDB&M bears S 40 $^{\circ}$ 19' 59" E, 3515.69 feet.
6. The existing permitted point of diversion is located within the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 22, T13N, R20E, MDB&M or at a point from which the W $\frac{1}{4}$ corner of Section 15, T13N, R20E, MDB&M bears N 44 $^{\circ}$ 46' W, a distance of 3712 feet.
7. Proposed place of use No change.
8. Existing place of use W $\frac{1}{2}$ SE $\frac{1}{4}$, SW $\frac{1}{4}$ Section 15; S $\frac{1}{2}$ S $\frac{1}{2}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 16; SE $\frac{1}{4}$ Section 17; all in T13N, R20E, MDB&M, Douglas County, Nevada (680 acres more or less).
9. Use will be from 1 January to 31 December of each year.
10. Use was permitted from 1 January to 31 December of each year.
11. Description of proposed works underground collection system and ditches to a booster pump station which pumps into a distribution system which carries water to wheel lines, hand set and pivot sprinkler systems
12. Estimated cost of works \$40,000.00 (Approximately)
13. Estimated time required to construct works 1 year
14. Estimated time required to complete the application of water to beneficial use 2 years.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of seeps and springs as heretofore granted under Permit 44684 is issued subject to the terms and conditions imposed in said Permit 44684 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 65223, 65224, 65225, 65226, 65227, 65228, 65229, and 65230 shall not exceed 2,720.0 acre-feet annually.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

February 7, 2001

Proof of completion of work shall be filed before:

March 7, 2001

Water must be placed to beneficial use on or before:

February 7, 2002

Proof of the application of water to beneficial use shall be filed on or before:

March 7, 2002

Map in support of proof of beneficial use shall be filed on or before:


