The applicant Michael S. and Deborah J. Gifford, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is an underground source
2. The amount of water applied for is 0.03.c.f.s second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for Quasi-Municipal purposes
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point within the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 33, T.19S., R.60E., M.D.B.&M., or at a point from which the Southwest (SW) Section corner of said Section 33 bears South 16^o 04' 30" West a distance of 1141.72 feet.
6. Place of Use Within the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 33, Township 19 South, Range 60 east, M.D.B.&M., approximately two (2.0) acres.
7. Use will begin about January 1st and end about December 31st of each year.
8. Description of proposed works well, pump, electric motor, domestic water lines from three houses to 1500 three (3) 60-gallon storage tanks. (pressurized)
9. Estimated cost of works \$12,000.00
10. Estimated time required to construct works completed
11. Estimated time required to complete the application of water to beneficial use
12. Remarks: The water will be used on three (3) lots of a minor subdivision

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permit 65319 provides water service to three lots described by Clark County Assessor's Parcel Nos. 125-33-401-002, 125-33-401-003, and 125-33-401-009.

This permit is issued subject to the State Engineer's Amended Order 1054, dated April 15, 1992.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.03 cubic feet per second, **but not to exceed 1.095 million gallons annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

July 12, 2002

Proof of completion of work shall be filed before:

August 12, 2002

Water must be placed to beneficial use on or before:

July 12, 2005

Proof of the application of water to beneficial use shall be filed on or before:

August 12, 2005

Map in support of proof of beneficial use shall be filed on or before:


