The applicant Sierra Pacific Power Company, hereby makes application for permission to change the Point of Diversion, Place and Manner of Use of a portion of water heretofore appropriated under Claim No. 221 and 478, 479 of the Truckee River Decree, said Decree entered by the District Court of the United States for Nevada in that certain action entitled, "The United States of America vs. Orr Water Ditch Company, et al., Defendants", in Equity Docket A-3.

1. The source of water is the Truckee River.
2. The amount of water to be changed .49 acre feet Claim 221 and 8.76 acre feet Claim 478, 479.
3. The water to be used for Municipal and Domestic
4. The water heretofore permitted for as Decreed
5. The water is to be diverted at the following point The points of diversion of Sierra Pacific's existing water treatment plants as described in attached Exhibit "A" and as shown on the map supporting Application No. 58882 on file with the Division of Water Resources, State of Nevada.
6. The existing permitted point of diversion is located within See attached Exhibit "C".
7. Proposed place of use See attached Exhibit "B" as described in Application No. 62141 and shown on the map accompanying said application on file with the Division of Water Resources, State of Nevada.
8. Existing place of use Claim 221 - .15 acres being removed from irrigation in the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 5, T.18N., R.20E., M.D.B.&M., appurtenant to Parcel 164-222-28 as shown on NDWR TR Map 28. Claim 478, 479 - 1.30 acres in the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$, and .89 acres in the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$, Section 29, T.19N., R.20E., M.D.B.&M., being removed from irrigation. Appurtenant to a fraction of Washoe County APN 015-210-26 and as illustrated on the supporting map.
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from As Decreed
11. Description of proposed works Water will be diverted by existing SPPCo. facilities, treated and placed into the existing distribution system.

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of the Truckee River as heretofore granted under Claim 221/222 and 478/479, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.



The following describes the multiple points of diversion for Sierra Pacific Power Company Water Treatment Plants, which are shown on the map accompanying Application No. 58882 on file with the State of Nevada, Division of Water Resources, more particularly described as follows:

STEAMBOAT CANAL (HUNTER CREEK RESERVOIR):

The existing point of diversion is situated within the Northeast one-quarter of the Southwest one-quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 31, T.19N., R.18E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 31 bears South 62°04' East, a distance of 3,195.00 feet.

HIGHLAND DITCH (HIGHLAND RESERVOIR):

The existing point of diversion is situated within the Southwest one-quarter of the Southeast one-quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 9, T.19N., R.18E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 9 bears South 75°16' East, a distance of 1,650.00 feet.

IDLEWILD TREATMENT PLANT:

The existing point of diversion is situated within the Southeast one-quarter of the Southeast one-quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 10, T.19N., R.19E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 10 bears South 69°57'58" East, a distance of 842.34 feet.

NORTH TRUCKEE DITCH (GLENDALE TREATMENT PLANT):

The existing point of diversion is situated within the Southwest one-quarter of the Northeast one-quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 7, T.19N., R.20E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Northeast corner of said Section 7 bears North 39°28' East, a distance of 3,015.00 feet.

ORR DITCH PUMP STATION (CHALK BLUFF TREATMENT PLANT):

The point of diversion is situated within the Northeast one-quarter of the Southeast one-quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 17, T.19N., R.19E., M.D.B.&M., Washoe County, Nevada from said point of diversion the Northeast corner of said Section 17 bears North 15°39'36" East, a distance of 3,264.77 feet.

ORR DITCH (CHALK BLUFF TREATMENT PLANT):

The point of diversion is situated within the Northeast one-quarter of the Southwest one-quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 17, T.19N., R.19E., M.D.B.&M., Washoe County, Nevada from said point of diversion the Southwest corner of said Section 17 bears South 44°40' West, a distance of 3,211.00 feet.






EXHIBIT "C"

Existing Point of Diversion

Claim 221 - NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 19, T. 19N., R. 19E., M.D.B. & M., or at a point from which the NW corner of Section 20, said Township and Range, bears S. 88° 05' E., a distance of 2620.00 feet. Lake Ditch per Orr Ditch Decree.

Claim 478, 479 - NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 11, T. 19N., R. 19E., M.D.B. & M., or at a point from which the NW Corner of Section 14, said Township and Range, bears S. 69° 15' E., a distance of 3640.0 feet. Cochran Ditch per Orr Ditch Decree.
