PIERSON, hereby makes application for permission to change the existing place of use of a portion of water heretofore appropriated under Truckee-Carson Irrigation District Serial No. 94-1 & 329 United States of America v. Orr Ditch Co. in Equity No. A-3, Claim No. 3; United States of America v. Alpine Land and Reservoir Co., No. D-183; Both in the Federal District Court of Nevada

1. The source of water is Truckee River & Carson River
2. The amount of water to be changed 9.63 ac. ft.


