The applicant **UTILITIES, INC. OF NEVADA**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground source developed to alleviate potential hazard from rising groundwater.**

2. The amount of water applied for is **0.5 CFS** second-feet

(a) If stored in reservoir give number of acre-feet

3. The water to be used for **Wildlife Purposes**

4. If use is for:

(a) Irrigation, state number of acres to be irrigated

(b) Stockwater, state number and kinds of animals to be watered

(c) Other use (describe fully under No. 12. "Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point **NW¹/₄ NW¹/₄ Section 21, T21N, R18E, MDM; or at a point from which the Northwest corner of said Section 21 bears N 04° 36' 29" W a distance of 1192 feet.**

6. Place of Use **All of Section 9; W¹/₂ and portions of NW¹/₄ NE¹/₄, SW¹/₄ NE¹/₄ Section 15; all of Section 16; S¹/₂ SE¹/₄, S¹/₂ SW¹/₄ and portion of N¹/₂ SE¹/₄ Section 17; portions of NE¹/₄ NE¹/₄ (LOT 9), SE¹/₄ NE¹/₄ (Lot 10), NE¹/₄ SE¹/₄ (Lot 11), SE¹/₄ SE¹/₄ (Lot 12) Section 19; NE¹/₄ and portions of NE¹/₄ SW¹/₄, SW¹/₄ SW¹/₄ and NW¹/₄ SW¹/₄ Section 20; N¹/₂ NW¹/₄, SE¹/₄ NW¹/₄, NE¹/₄, N¹/₂ SE¹/₄, SE¹/₄ SE¹/₄, portions of SW¹/₄ SE¹/₄, SW¹/₄ NW¹/₄, NE¹/₄ SW¹/₄ Section 21 all in T21N, R18E, MDM.**

7. Use will begin about **January 1** and end about **December 31** of each year.

8. Description of proposed works **Construct well or group of shallow collection wells, pump(s), transmission and distribution mains and appurtenances.**

9. Estimated cost of works **\$200,000 more or less**

10. Estimated time required to construct works **5 years**

11. Estimated time required to complete the application of water to beneficial use **10 years**

12. Remarks: **Water would be pumped to support wetlands which are existing or may be proposed along the north side of White Lake. Annual use will not exceed 100 acre feet.**
