The applicant **Claribel Dansby** hereby makes application for permission to change the **Point of Diversion & Place of Use** of water heretofore appropriated under **Permit 60443**

1. The source of water is **an underground source in Nye County, Nv**
2. The amount of water to be changed **0.02 CFS., not to exceed 5.08 AFA.**
3. The water to be used for **Irrigation & Domestic Use**
4. The water heretofore permitted for **Irrigation & Domestic Use**
5. The water is to be diverted at the following point **within the NW. ¼ SW. ¼ of Sec. 15, T. 17S., R. 49E., MDM., or at a point from which the SW. corner of said Section 15 bears S 01° 06' 37" W., a distancer of 2448 feet**
6. The existing permitted point of diversion is located within **the NE. ¼ of NW. ¼ of Sec. 15, T. 16S., R. 48E., MDM., or at a point from which the NW. corner of said section 15 bears N. 86° 36' 18" W., a distance of 1880 feet**
7. Proposed place of use
29.16 acres within the NW.¼ SW.¼ of Section 15, T. 17S., R. 49E., MDM.

10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **A 12" Dia. X 250' deep driven well, cased all the way with a 75 hp. submersible pump, and wire**
12. Estimated cost of works **\$45,000**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 60443 is issued subject to the terms and conditions imposed in said Permit 60443 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The total combined duty of water under Permits 65401, 65635, 65636, and 65637 shall not exceed 316.16 acre-feet annually for the irrigation of 64.04 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.02 cubic feet per second, **but not to exceed 5.08 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

February 17, 2002

Proof of completion of work shall be filed before:

March 17, 2002

Water must be placed to beneficial use on or before:

February 17, 2005

Proof of the application of water to beneficial use shall be filed on or before:

March 17, 2005

Map in support of proof of beneficial use shall be filed on or before:

March 17, 2005
